Dear Prospective 2019 ALA Summer School Student,

Attached you will find the 2019 Summer School application. Please fill out all forms entirely and return all forms *as soon as possible* to the front office in order to secure a seat for summer school. Review the 2019 Summer School Student Agreement below to ensure your success during summer school.

2019 Summer School Student Agreement

1. Attendance & Earning Credit

- a. Summer School runs from Monday through Thursday, from June 3rd through June 27th. There are no classes on Fridays.
- b. Students must attend one of two sessions: 8:00 AM to 12:00 PM or 12:30 PM to 4:30 PM
- c. All students are required to attend the class for which they are registered.
- d. After an accumulated **8 hours marked absent** (either unexcused *or excused*) during summer school, students will be dropped for lack of attendance. Attendance is taken every hour and students absent for more than 20 minutes of an hour block will be counted as unexcused for that hour.
- e. Students must remain on campus in their assigned classroom during their scheduled classes. Failure to do so may result in an intervention contract and ultimately lead to being dropped for lack of attendance.
- f. Students may complete only 1 class for the duration of Summer School. ****ALA students only** - Upon completion, a second class may be taken upon approval by the ALA Principal or the Academic and Career Counselor.
- g. **Students completing English 9B, 10B, 11B or Algebra 1B, Geometry B or Algebra 2B must complete the appropriate AzMERIT test in order to receive credit for the course.**
- h. Students must meet with the academic advisor or guidance counselor at their home school to complete the "Request to Take Coursework from Outside Mesa Public Schools" form to ensure transferability prior to the beginning of Summer School. Transcripts will be mailed to your school upon the close of summer school the week of July 1st.

2. Signing In and Out

- a. ALL STUDENTS ARE EXPECTED TO SIGN IN AND OUT AT THE FRONT DESK EVERY DAY.
- b. If leaving campus for any reason, each student is required to sign out at the front office. Once back at campus, each student is required to sign back in at the front office.
- c. Students over 18 may sign themselves in and out.
- d. Students under 18 may not leave campus for the day at a time different than their schedule indicates. They may leave campus during lunch, if parent/guardian permits.

3. Dress Code & Behavior

- a. You are expected to act as an adult. Poor behavior will not be tolerated. If poor behavior is continuous, you will be asked to leave summer school.
- b. Clothing must not denote gang affiliation through overt colors or symbols.
- c. Clothing may not contain any red or blue
- d. Clothing must not display drug or alcohol use & may not be revealing or see-through.
- e. Students must not be on campus if under the influence of any illegal substance. If medication is required by the student, then a doctor’s prescription must accompany the student’s medication. The medication must be locked up in the front office while the student is on campus.
- f. Students may not have any illegal substance in their possession while on campus. Failure to follow this directive will result in immediate dismissal from the program.
